

REGULATIONS OF THE 9TH ACADEMY OF IMMUNOHISTOCHEMISTRY
9-11.04.2025

(“REGULATIONS”)

§ 1

Date and Duration

1. These Regulations define the rights and obligations of Participants of the *9th Academy of Immunohistochemistry* (hereinafter referred to as the "Conference"), which will take place on 9-11.04.2025 in Kraków, at the Jagiellonian University Auditorium Maximum (33, Krupnicza Street, 31-123 Krakow)
2. The Conference is organized by the Jagiellonian University – Collegium Medicum, Chair of Pathomorphology, 16, Grzegorzeczka Street, 31-531 Krakow and Maria Skłodowska-Curie National Research Institute of Oncology – Krakow branch, 11, Garncarska Street, 31-115 Krakow (hereinafter referred to as the "Organizer"). The technological partner of the course is Cancer Center Sp. z o.o., 5 Goralska Street, 53-610 Wroclaw (hereinafter referred to as the "Technological Partner").
3. A Participant of the Conference is any adult natural person with legal capacity who has registered for the Conference no later than March 31, 2025, as described in § 2 of these Regulations and has accepted the terms of participation set forth herein (hereinafter referred to as the "Participant").
4. The Regulations are made available to Participants on the Conference website <https://ihc-academy.cm-uj.krakow.pl> (hereinafter referred to as the "Conference Website") in both Polish and English. In case of discrepancies or doubts regarding the content, the Polish version shall prevail.
5. The Organizer reserves the right to amend the Regulations due to changes in generally applicable laws or to adjust the Conference format to comply with restrictions, mandates, and prohibitions related to a pandemic or other safety measures. Amendments take effect within 7 days of being published on the Conference Website. For Participants who have accepted the Regulations prior to amendments, the changes take effect 7 days after notification via email, unless the Participant objects within this period.
6. The Organizer may also amend the Regulations to make changes that do not negatively impact Participants' rights or to correct typographical or editorial errors. Such amendments take effect no earlier than 3 days after notification via email, provided no objections are raised.
7. The Organizer reserves the right to change the date and format of the Conference if holding it as originally planned becomes impossible or overly burdensome due to factors beyond the Organizer's control, such as pandemic-related restrictions. Changes will be announced promptly on the Conference Website.
8. The Organizer reserves the right to modify the Conference program, including the schedule and order of presentations. Changes will be announced promptly on the Conference Website. Such changes do not constitute amendments to the Regulations.

§ 2

Registration for the Conference

1. Participation in the Conference is subject to a fee and requires prior registration through the registration system (hereinafter referred to as the "System") available on <https://konferencje-uj.pl/> (hereinafter referred to as the "Registration Page"). Participants must provide the following information: full name, email address, affiliation, and profession.
2. Details regarding registration procedures, deadlines, the registration fee (hereinafter referred to as the "Fee"), and payment methods are available on the Conference Website.
3. If a Participant decides to withdraw from the Conference, they must notify the Organizer promptly by email at konferencje@uj.edu.pl. Withdrawals made before March 14, 2025, will

entitle the Participant to a refund of the Fee (bank charges excluded). Withdrawals after this date will not qualify for a refund.

4. The Organizer is not responsible for incorrect or false data provided by Participants during registration.
5. The Conference is limited to a maximum of 100 Participants. Registration is confirmed on a first-come, first-served basis, confirmed by the Fee payment.
6. The Participant limit may be adjusted due to pandemic-related restrictions. In such cases, the Organizer will prioritize Participants based on registration order and notify any affected individuals by email. Participants unable to attend due to these restrictions will receive a refund of the Fee, if already paid, within 30 days.
7. By registering, Participants confirm their acceptance of the Regulations and grant the Organizer permissions, licenses, and authorizations as specified herein. Registration is completed upon submission of the required data and acceptance of the terms outlined in § 5-8 of these Regulations.
8. Participants gain the right to attend the Conference only after paying the Fee.

§ 3

General Rules for Participation

1. The Conference will feature lectures (hereinafter referred to as "Lectures"). The event will be conducted in English. Detailed information and the Conference program are available on the Conference Website.
2. Participants may ask questions after each Lecture, subject to time constraints and the Conference schedule. The Organizer will decide on the number of questions permitted.
3. Participants are reminded to respect intellectual property rights in any materials provided by the Organizer (hereinafter referred to as "Conference Materials"). These materials are for personal use only. Modifying, copying, transmitting, publicly performing, or using these materials for commercial purposes requires prior written consent from the Organizer or another authorized entity. Participants bear full responsibility for damages resulting from unauthorized use.

§ 4

Rights and Obligations of Participants

1. Upon arrival at the Conference venue, Participants must confirm their attendance at the reception desk located at the Auditorium Maximum.
2. Participants must comply with safety rules, health and safety regulations, fire safety laws, and any sanitary protocols in effect at the venue.
3. The Organizer is not liable for lost or misplaced items, including those left in clothing, bags, or luggage at the venue.
4. The Organizer is not responsible for incidents resulting from non-compliance with the Regulations or instructions from Conference staff or security personnel.
5. To ensure safety, the Organizer may use surveillance systems throughout the venue. The terms of this surveillance are specified in the Organizer's monitoring regulations available at [zarządzenie nr 34 Rektora Uniwersytetu Jagiellońskiego z 16 maja 2019 roku w sprawie: Regulations for Video Surveillance at the Jagiellonian University, as amended, available on the Jagiellonian University Public Information Bulletin.](#)

§ 5

Lectures

1. Lectures will be delivered by speakers (hereinafter referred to as "Speakers") selected by the Organizer to ensure high academic standards and thematic diversity.
2. Speakers must submit their presentations (hereinafter referred to as "Presentations") to the Organizer in electronic form by April 1, 2025.

3. Delivering a Lecture and granting the Organizer permissions, licenses, and authorizations specified in §§ 7-8 of the Regulations for the use of the Presentation and the Lecture, to the extent and in all fields of exploitation indicated therein, is free of charge and takes place for the statutory purposes of the Organizer, subject to separate agreements concluded with the Speaker.
4. Granting permissions, licenses, and authorizations specified in §§ 7-8 to the Organizer is voluntary but required for presenting the Lecture.

§ 6 Cancer Center Platform

To ensure the highest substantive level, the Organizer has partnered with a Technology Partner, whose responsibilities include:

- a) Providing access to the <https://cancercenter.ai/> platform, serving as a repository of scientific materials for Conference Participants.
- b) Presenting the functionalities and potential applications of the platform for medical purposes during the Conference.

To optimize the use of the platform and its features, the Organizer will share with the Technology Partner a database consisting of a list of Participants (name, surname, email address) obtained during event registration. This database will be used to create unique profiles for each Conference Participant, granting them access to the resources discussed during the event. Access to the resources will be provided via a link sent to the email address provided during registration through the coffee system.

§ 7 Copyright

1. The Speaker assumes full responsibility for the form and content of the Lecture.
2. The Speaker undertakes to prepare and deliver an original Lecture and guarantees that the Lecture will not infringe the rights or personal interests of third parties, nor will it include statements or opinions promoting hatred or discrimination against individuals based on race, culture, ethnicity, religion, worldview, or gender. Furthermore, the Lecture must not propagate ideologies or symbols associated with totalitarian regimes, contain other topics prohibited by generally applicable laws, or damage the good name of the Organizer.
3. Should any part of the Lecture include legally protected elements not owned by the Speaker, the Speaker guarantees they are authorized to use them to the extent necessary for the Lecture and to grant the Organizer a License with sublicensing rights as referred to in this section, without requiring the Organizer to obtain additional consents or permissions.
4. The Speaker grants the Organizer a non-exclusive, perpetual, worldwide, and unlimited license to use the Lecture. This license is granted to the Organizer upon the Speaker's delivery of the Lecture and includes the right to use the Lecture in the following manner: public performance for dissemination.
5. The Speaker grants the Organizer a non-exclusive, perpetual, worldwide, and unlimited license, including the right to grant sublicenses of the same scope, to use the Presentation accompanying the Lecture for informational, documentation, educational, and teaching purposes. In particular, the Speaker consents to its use via publication on the Internet, Intranet, and through any telecommunication services using any systems or devices, on the Organizer's Website, other websites managed by the Organizer, the Conference Website, and through its distribution to Participants as part of Conference Materials.
6. The license referred to in paragraph 4 above (hereinafter referred to as the "License") is granted to the Organizer upon the delivery of the Presentation and includes the following fields of use:
 - a) Fixation and reproduction of the Presentation – creating copies of the Presentation using digital techniques (e.g., USB drives).
 - b) Permanent or temporary duplication of the Presentation, in whole or in part, by any means and in any form.

- c) Dissemination of the Presentation – displaying, playing, broadcasting, rebroadcasting, and public sharing of the Presentation in a manner that allows Conference Participants to access it at a time and place of their choosing, using all available techniques, including via the Internet, Intranet, and other computer networks, and publishing the Presentation on websites.
 - d) Trading the original or copies on which the Presentation is fixed – introducing into circulation, lending, or renting the original or copies.
 - e) Creating and disseminating derivative works of the Presentation, including subsequent projects/materials based on the Presentation or its individual components, such as developing alternative graphic, color, or visual/spatial formats of the Presentation and using such derivative works in the manner and on all fields of exploitation specified in this section.
 - f) Using the Presentation and its individual components in advertising and promoting the Organizer or the University's activities domestically and abroad.
7. The License also includes the Organizer's right, and that of individuals acting on their behalf, to exercise derivative rights to the Presentation on all fields of exploitation mentioned in paragraphs 5–6 above, including the right to prepare adaptations, use and dispose of derivative works, and grant third parties the right to exercise the author's derivative rights to the Presentation to the same extent as exercised by the Organizer.
8. In the event that third parties raise claims against the Organizer and/or entities acting on its behalf and/or entities authorized by the Organizer to use the Presentation (hereinafter referred to as the "Authorized Entities") in relation to the Presentation or any of its components, the Speaker shall:
- a) release the Organizer and/or the Authorized Entities from such claims, to the extent to which the Speaker was obligated to acquire from third parties the rights to legally protected elements of the Presentation, including intellectual property rights and related rights to such elements, and to obtain permissions and authorizations referred to in this paragraph, and
 - b) bear full responsibility for any damages incurred by the Organizer and/or the Authorized Entities resulting from claims mentioned in point (a) above, including, but not limited to, damages related to claims for compensation for the unlawful use of the Presentation or the unlawful use of its individual components.

§ 8 Personal Data Protection

Pursuant to Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter referred to as the "GDPR"), the Jagiellonian University hereby informs you that:

1. The Data Controller for the Participant's personal data is: Jagiellonian University, 24, Golebia Street, 31-007, Krakow, Poland, represented by the JU Rector. Jagiellonian University has appointed a Data Protection Officer, 4 Czapskich Street, 31-110 Krakow. You may contact the Data Protection Officer via email: iod@uj.edu.pl or by phone: 0048 12 663 12 25, Monday to Friday, between 8:00 a.m. and 3:00 p.m.
2. The Participant's personal data will be processed for the following purposes:
 - a) To perform the agreement, the subject of which is participation in the *9th Academy of Immunohistochemistry* and to register participation in the Conference, as well as to accept submissions from Participants willing to deliver a Lecture, based on Article 6(1)(b) GDPR, i.e., on the basis of the agreement concluded through the acceptance of the Rules and Regulations.
 - b) To ensure the security of the Event in accordance with the Jagiellonian University Visual Monitoring Regulations available at <https://bip.uj.edu.pl/> and the information

obligation regarding the processing of image data in video monitoring available at <https://iod.uj.edu.pl/monitoring-wizyjny> based on Article 6(1)(e) GDPR with respect to data obtained via visual monitoring.

3. Provision of personal data by the Participant is necessary for the conclusion of the agreement, participation in the Conference, preparation of the Presentation, and delivery of the Lecture.
4. Personal data may be disclosed to entities authorized to receive such data under universally applicable legal provisions.
5. Recipients of the Participant's personal data include entities providing IT and organizational support for the Conference, including the provider of software used for Conference registration and the technological partner administering the platform <https://cancercenter.ai/>.
6. Personal data will not be transferred to third countries (outside the European Economic Area) or international organizations.
7. The Participant's personal data specified in point 2(a) above will be stored for the duration of the Conference, until its final settlement and closure, and for the period necessary to resolve any claims arising from the performance of the agreement referred to in point 2(a). Data from video monitoring may be processed for up to 3 months.
8. Personal data provided in the Registration System will not be disclosed to third parties.
9. If a Participant invited to deliver a Lecture voluntarily includes personal data in the content of the Lecture, such data will be processed on the Platform <https://cancercenter.ai/> for informational and documentation purposes.
10. The Participant has the right to:
 - a) Obtain information about the processing of their personal data and the rights granted under GDPR;
 - b) Access their personal data and request its rectification;
 - c) Request the deletion of personal data from the Controller's records (unless further processing is necessary to comply with a legal obligation or to establish, exercise, or defend legal claims);
 - d) Restrict processing, transfer data, and object to processing in cases and under conditions specified by GDPR.
11. The Participant's personal data will not be subject to automated decision-making or profiling.
12. The Participant has the right to file a complaint with the President of the Personal Data Protection Office if they believe that the processing of their personal data violates GDPR.

§ 9 Final Provisions

1. This Regulation is made available to the Conference Participants on the Conference Website and enters into force on the date of its publication on the aforementioned website.
2. In the event of the cancellation of the Conference, the Organizer shall promptly inform the Participants via the Conference Website. The Organizer shall not be liable to the Participants or Speakers for any compensation or damages arising from such cancellation, nor for the reimbursement of any costs incurred in connection with participation in the Event, except for the refund of the Fee.
3. Matters not regulated by this Regulation shall be governed by the generally applicable provisions of Polish law.
4. Any disputes arising hereunder shall be subject to the jurisdiction of the Polish common courts of general jurisdiction.
